SUBJECT: Approval of Resolution Number 07-12 designating the Sultan Shindig as a Community Event and prohibiting dogs, other pets, or other domestic animals, and the riding of bicycles, skateboards, and scooters in designated areas.

SUMMARY:

The attached Resolution establishes the Sultan Shindig as a Community Event this year on July 13, 14, and 15 between the hours of 7:00 a.m. and 1:00 a.m. The Resolution also prohibits dogs, other pets, or other domestic animals from entering the area, and prohibits event attendees from riding bicycles, skateboards, and scooters on the property designated for the Shindig.

There are no other changes to the Resolution 07-12 from Resolution 06-05 adopted by City Council in 2006. The Resolution establishes Shindig as a sanctioned community event and provides the vehicle for applying for the Special Use Permit for the noise associated with the event. The Resolution also sanctions road closures as described on Exhibit A. A Special Event Permit for noise has been applied for by the Sultan Shindig Committee.

**A RESOLUTION BY THE CITY OF SULTAN CITY COUNCIL,
DESIGNATING "SULTAN SHIN DIG" AS A COMMUNITY EVENT AND
PROHIBITING DOGS, OTHER PETS, OR OTHER DOMESTIC ANIMALS
AND BICYCLES, SKATEBOARDS AND SCOOTERS FROM DESIGNATED
AREAS WHERE THE "SULTAN SHIN DIG" WILL BE CONDUCTED**

WHEREAS, the City of Sultan designates the "Sultan Shin Dig" as a Community Event to be held on July 13, 14, and 15, 2007 between the hours of 7 AM and 1AM the following mornings; and

WHEREAS, the City Council and the "Sultan Shin Dig" committee desires to protect the visitors and participants of the Sultan Shin Dig from dogs, other pets or other domestic animals and bicycle, skateboard and scooter riders within the designated areas where the Sultan Shin Dig will be conducted which is described on Exhibit A; and

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SULTAN, WASHINGTON RESOLVES THAT:

Section 1. The City Council hereby designates the "Sultan Shin Dig" as a Community Event, which will be held on July 13, 14 and 15, 2007 between the hours of 7 AM and 1AM the following mornings within the area designated on "Exhibit A".

Section 2. The City Council hereby prohibits Dogs, Pets, or Domestic animals to stray or enter within the area designated on "Exhibit A" as provided for in, SMC Chapter 6.04, Section 6.04.032.

Section 3. The City Council hereby prohibits the riding of Bicycles, Skateboards, and Scooters within the area designated on "Exhibit A" as provided for in SMC Chapter 12.25.

Section 4. Effective Date: This resolution shall be in full force and effective upon approval by the City Council.
