ORDINANCE 1324-20**

**AN ORDINANCE OF THE CITY OF SULTAN AMENDING THE 2020 BUDGET  
ADOPTED UNDER ORDINANCE 1316-19; PROVIDING FOR SEVERABILITY;  
AND ESTABLISHING AN EFFECTIVE DATE**

WHEREAS, the City is required under state law to have a balanced budget; and

WHEREAS, the 2020 budget was adopted under Ordinance 1316-19 in December 2019; and

WHEREAS, a public hearing on the proposed amendments were held on June 25, 2020; and

WHEREAS, it is necessary to amend the budget to adjust for unanticipated revenues or expenditures; now therefore

THE CITY COUNCIL OF THE CITY OF SULTAN DO ORDAIN AS FOLLOWS:

Section 1: The 2020 Budget as authorized under Ordinance 1316-19 for revenues and expenditures for the operation of the City of Sultan for the fiscal year ending December 31, 2020 is amended to increase/decrease in the following amounts:

Section 2: The budget for the year 2020 is amended to include the changes as outlined above and filed in the office of the City Clerk.

Section 3. Severability. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

Section 4. Effective Date. This Ordinance shall be published in the official newspaper of the City and shall take effect and be in full force five (5) days after the date of publication.
